

MAKING MIGRATION WORK FOR SUSTAINABLE DEVELOPMENT TUNISIA

2012 - 2023

In Tunisia, high youth unemployment rates and stagnant economic growth drive both regular and irregular migration. With 1.8 million Tunisians living abroad, engaging with and empowering this skilled diaspora community offers many possibilities to enhance Tunisia's local socioeconomic prosperity. In addition, irregular migration from Tunisia to Europe has increased significantly, with 74,760 arrivals to Italy from Tunisia, from 1st January – 31st August 2023, compared to 16,283 in the same period in 2022.

As part of all three phases of the **M4SD Programme** since 2011, IOM and UNDP have supported the Tunisian government to mainstream

migration in sectorial policies related to employment and youth. To better coordinate, design, implement and monitor policies with migration considerations, the knowledge and capacities of local and national government practitioners has been strengthened and the overall understanding and operationalization of the nexus between migration and sustainable development has become part and parcel of their work. In addition, the Tunisian government has strengthened their long-term partnership with diaspora organizations and private sector actors to sustainability and jointly work toward youth employability and local development.

Technical support provided to mainstream migration into Local Economic Development Plan with a focus on social cohesion, health and sports

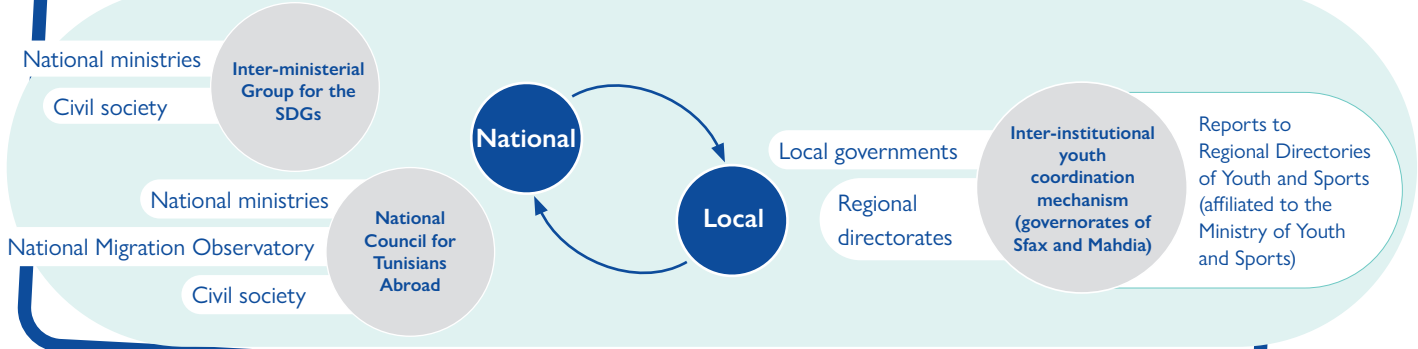

- Private sector mapping study elaborated, which include a database of a) 160+ companies in Tunisia and Switzerland interested in hiring migrants as interns and b) 54+ companies in Switzerland with open internship positions
- Guidelines and recommendations for implementing skills mobility partnerships elaborated
- Pre-departure curriculum developed for Tunisians' and migrants' interns, incl. guidelines for individual counselling sessions and training for career counsellors, employment agencies
- 300 youth from 8 countries gathered at Youth Symposium on the Future to discuss emerging issues and themes related to youth and migration
- Enhanced mobilization of Tunisian diaspora by building capacities of 56 enterprises (Mobi-Tre phase 1) and secured diaspora's support for the creation of 30 new enterprises
- 2 Tunisian diaspora associations supported to enhance their contributions to local development initiatives: PONTES and FTCR
